Dear Mr. Berge

We thank you for your fax dated April 7, 2008 to Mr. Haltiner. We have the pleasure to answer you in his name.

As you probably know, the Swiss Federal Banking Commission (SFBC) is the supervisory authority for the banking system, the collective investment schemes, the securities and derivatives exchanges and the securities dealers in Switzerland. In particular, any entity wishing to carry on business activities as a bank or securities dealer has to be duly licensed by the SFBC. You have already checked the list of all regulated institutions which is posted on our website www.ebk.admin.ch (Authorised institutions).

VIKING Ship Finance Limited is/was not authorised by the SFBC for an activity as a bank, securities dealer or in the domain of collective investment schemes. The company is registered in the trade register of the Canton of Zurich as a provider and intermediary von financial services in the shipping industry, financing of other companies as well as administrative services.

According to the inscription in the trade register, the formerly called Finance Company Viking moved before 1991 to Zürich, it's former head office was in Freiburg. As you already know, VIKING Ship Finance Limited is in liquidation. Mr. Stein Wessel-Aas, Oslo and Dr. Robert Sutz, Zürich are mentioned as liquidators. In conformity with the decision of the company's General Meeting of January 19, 2005, VIKING Ship Finance Limited in Liquidation was closed down.
