Dear Sirs/Mss,

Earlier this year my live-in partner had a private lunch with the Luxembourg ambassador to China, Mr. Carlo Krieger. During this meeting he told her how he and his foreign minister, Mr. Jean Asselborn, had been trawling the South Pacific for support for Luxembourg's candidacy for the vacant rotating non-permanent seat in the United Nations Security Council. The election will take place in New York on October 18 2012.

Make no mistake; Luxembourg couldn't care less about the island states of the Pacific as such!

We have lived in Luxembourg for more than five years. During the course of these five years, we have gathered solid documentation on the Luxembourg Government's continuous and integrated (as part of its financial policy) violations on Human Rights and its direct involvement in and protection of international financial crimes. It seems safe to conclude that Luxembourg and its financial supervisory body (CSSF) is for a greater part responsible for the 2008 financial crisis, the so called; Lehman Brothers effect.

This spring we were forced to flee our home and Luxembourg as we were warned by an "inside-lawyer" that the government had issued a death warrant on me and my family. As my live-in partner is a PhD Scholar in Human Rights at the University of Luxembourg, this death warrant effectively impedes her studies, which – according to the *insider* – was the government's and the EU Commissioner on Justice and Human Rights' (Ms. [Viviane Reding](#)) planned outcome.

Luxembourg and its leader, [Jean-Claude Juncker](#), is corrupt to the core, and should by this reason obviously not receive support from anyone. Luxembourg will, if becoming a member of the Security Council, jeopardize the fragile peace around the world, and will only contribute to the escalation of financial crimes, global wars and unrests, as this country – by its hostile and illegal financial policy which includes the acceptance and protection of international financial crimes, and the facilitation, funding and control of tax evasion, money laundering, illegal arms dealings, wars and coup d'états – has only one mission: Absolute global control through its banking and financial institutions.

This might come as a surprise to some of you, whereas others would at first glance think that this must be just another conspiracy theory. It is not. My conclusions are based upon undisputable facts. In this regard, please find enclosed our letter to Transparency International (TI) of August 7 2012, describing and documenting the true "Western Democracy" (*the big black metallic door without a bell*) in both Switzerland and Luxembourg, as well as the Governmental death threats we received this spring. Furthermore you will find enclosed an interesting e-mail correspondence which followed our approach to TI, indicating that even TI is controlled by the Luxembourg Government.

Reading these two documents – in which the latter contains some alarming statements from a Luxembourg Editor in Chief – gives you sufficient evidence enabling you to conclude that Luxembourg, its government, is corrupt to the core and is a looming danger not only to the UN Security Council, but to the world peace, the idea of the democracy, and to the very idea of the *free man*. Let me finally remind you that this so called democracy – which in fact is a dictatorship – represents the worst part of any given criminal organization, and is responsible for the death warrant that has been issued against us, which is the reason why we fear for our lives, even here in the Pacific. As is mentioned in the letter to TI, the Luxembourg government has *already* assassinated one "unwelcome" person.

With all due respect, I urge all island states, members of the Pacific Forum, to refrain from any agreements / deals / diplomatic bargaining with Luxembourg, regardless of what this country offer of money and promises of potential wealth through aid, chequebook diplomacy, bribery or its alike, in return for the people of the Pacific's votes.

This country must not become a member of the United Nations Security Council!
